

These General Conditions regulate the use and access to the Internet service provided by CAMPING OTUR S.L., whose registered office is located at Carretera de la Playa de Otur S/N, D.P. 33792, Otur, Valdés, Asturias, and with VAT number: B-79281853, registered in the Mercantile Registry of Madrid, First Registration of sheet no. 14,578-1. Folio 185. Volume: 9982 General 998 of Section 4<sup>a</sup> of the Companies Book, made available to Users through <https://www.campingotur.es>, hereinafter referred to as the Website. In accordance with the provisions of the LSSICE, CAMPING OTUR S.L. is an establishment registered in the Registry of Companies and Tourist Activities of the Principality of Asturias with registration number: C-52-AS.

1.- Use of this Website: These General Conditions regulate the operation of the service of the Website provided by CAMPING OTUR S.L. to the user, its main objective being to inform about our services and who we are. The use of the Website grants the status of user, and implies the full acceptance by the user of all the Terms of Use of the Website in force at the time of access to it, so if the user does not agree with any of the conditions established here, they should not use this Website. Likewise, the user undertakes not to use the Website, nor the information published therein, for illicit purposes or effects, contrary to the content of these General Conditions, harmful to the rights or interests of third parties, or in any way that may damage, disable, overload, deteriorate the Website and the information provided therein or prevent the normal use and enjoyment of the Website by other users. The user must refrain from obtaining information, messages, graphics, drawings, sound and/or image files, photographs, software, and, in general, any kind of material accessible through the Website or its services, using means other than those made available to them, or generally those that are commonly used on the Internet.

2.- Right to modify the Website, right to restrict access to the Website and right to suspend the operation of the Website: CAMPING OTUR S.L. reserves the right to modify at any time, without prior notice, the presentation or configuration of the Website, as well as the information, services, these Terms of Use of the Website, as well as any other general or specific conditions, instructions or notices that may be applicable. These modifications will be made to improve user services, according to market trends. CAMPING OTUR S.L. reserves the right to suspend, interrupt or cease the operation of the Website, or restrict its access, partially or totally, individually or collectively, temporarily or permanently, at any time.

3.- Web Navigation Cookies: The service provider of the Website CAMPING OTUR S.L. uses system cookies solely for the purpose of facilitating navigation for the user. These files are never used to collect personal data. They are only used to improve navigation on the Website and reduce the loading time of Web elements. However, if the user does not wish to use these cookies, they can disable them from the options of their Web browser. They can also delete these files without suffering alterations in the quality of the website; the only effect of this change in configuration is a longer loading time for the Website, as the files will not be stored in the cache memory of their computer.

4.- Access and use of the Website is free: The provision of the service of the Website by the user is free and does not require prior subscription or registration. Any user who wishes to establish a link or carry out any similar action related to the Website must be previously authorized by CAMPING OTUR S.L. Any other use, transfer to third parties, communication, disclosure of the contents in whole or in part, publicly or privately, is prohibited. CAMPING OTUR S.L. reserves the right to exercise civil and criminal actions that correspond to demand compliance with this clause and claim damages.

6.- Intellectual and Industrial Property Rights: The user acknowledges and accepts that all Industrial and Intellectual Property rights over the contents and/or any other elements inserted in the Website (including, without limitation, trademarks, logos, trade names, texts, images, graphics, designs, sounds, databases, software, flowcharts, presentation, "look-and-feel," audio, and video) belong to CAMPING OTUR S.L. and/or third parties. 7.- Exclusion of warranties and liability. 7.1.- Website operation. CAMPING OTUR S.L. does not guarantee the availability and continuity of the operation of the Website and will not be liable in any case for damages and losses that may arise from the lack of availability or accessibility to the Website or to those other sites with which a link has been established; the interruption in the operation of the Website or computer failures, telephone breakdowns, disconnections, delays, or blockages caused by deficiencies or overloads in the telephone lines, in the Internet system, or in other electronic systems produced during its operation; the unsuitability of the Website for the specific needs of users and other damages that may be caused by third parties through unauthorized intrusions beyond the control of CAMPING OTUR S.L. The waiver by any party to demand at a specific time the fulfillment of any of the conditions stipulated here will not imply a general waiver of compliance with another condition or conditions, nor will it create an acquired right for the other party.

9.- Applicable law and jurisdiction. The provision of the Website service and these Terms of Use of the Website are governed by the applicable legislation in the territorial framework of the European Union and, specifically, by the laws that make up the Spanish legal system applicable to the information society services and electronic commerce and the Spanish legislation on the protection of personal data. For any discrepancy in the execution, interpretation, compliance with these conditions, or the relationships between the user and CAMPING OTUR S.L., both parties, with express waiver of any other jurisdiction that may correspond, submit to the exclusive jurisdiction and competence of the Courts and Tribunals of Asturias.

10.- Privacy and Confidentiality Policy for the personal data that users provide freely and voluntarily: 10.1. Identification of the File Manager and recipients of the information. We inform you, in accordance with the provisions of Organic Law 3/2018 of December 5 on the Protection of Personal Data (LOPD) and the GDPR of April 27, 2016, that your personal data are managed and controlled through specific and independent data processing sheets associated with the data received through electronic forms or CVs provided via email by the interested parties. 10.2 Purpose of data processing. The exercise of your rights of access, rectification, deletion/forgetting, opposition, limitation, and portability of your personal data that are part of our file is guaranteed. The Website has adopted the necessary technical and organizational measures, according to the level of security of data protection that legally corresponds to it, to guarantee the security of the processing of personal data that make up its automated file. However, the user must be aware that currently security measures on the Internet are not impregnable and, therefore, they are not safe from possible illegal and improper intrusions, which would not be the responsibility of CAMPING OTUR S.L., since it has acted with due diligence to protect the data as determined by law. 10.5 Update of personal data.
